ORDINANCE NO. 304-2024

(Duly Adopted 5th day of February 2024)

AN ORDINANCE OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, AMENDING TITLE VII, CHAPTER 71 OF THE TATAMY BOROUGH, PENNSYLVANIA, CODE OF ORDINANCES, TRAFFIC CODE, TRAFFIC REGULATIONS, CREATING SECTION 71.23, ONE WAY ROADWAY.

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL FOR TATAMY BOROUGH, NORTHAMPTON COUNTY, PENNSYLVANIA, AND IT IS HEREBY ORDAINED AND ENACTED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

SECTION 1. PURPOSE, FINDINGS AND DECLARATION OF POLICY.

WHEREAS, the Borough has the authority to regulate and prescribe rules and regulations for traffic and parking; and

WHEREAS, the Borough is to promote the public safety, health, and welfare by establishing certain streets in the Borough of Tatamy, as one-way streets; and

WHEREFORE, the borough hereby amends Title VII of the Borough of Tatamy, Codified Ordinances, Traffic Code, Section 71, Traffic Regulation, creating subsection 71.23, describing One Way Roadway Traffic.

SECTION 2. DEFINITIONS.

For the purposes of this Ordinance, the following definitions shall apply:

- "One-way street" means a street on which vehicular traffic is permitted to move in only one direction.
- "Traffic control devices" means a sign, signal, marking, or other device placed on or near a street or highway by lawful authority to regulate, warn, or guide traffic.

SECTION 3. ESTABLISHMENT OF ONE-WAY STREETS.

The following streets in Borough of Tatamy, Northampton County, are hereby established as a one-way street.

South 4th Street

Beginning at Main Street & South Fourth Street,

Southward and ending at Broad Street and South 4th Street.

SECTION 4. ENFORCEMENT

The Borough Police Department is hereby authorized to enforce the provisions of this Ordinance.

SECTION 5. REPEALER.

All Ordinances and parts of Ordinances inconsistent herewith are hereby specifically repealed.

SECTION 4. SEVERABILITY.

The provisions of this Ordinance shall be severable and, if any provisions thereof shall be declared unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent of the Borough of Tatamy that this Ordinance would have been enacted as otherwise set forth had such unconstitutional, illegal, or invalid provision(s) not been included herein.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall take effect immediately and be in force from and after its passage.
