Regular Monthly Council Meeting Minutes

CALL TO ORDER

Council President Bob Hayes calls the meeting to order at 7:00PM.

ROLL CALL

READING, AMENDING & APPROVAL OF AGENDA

Councilman Lester makes a motion to approve/amend agenda. Councilwoman Frace seconds this motion. Motion passes unanimously.

Wade Sandt asked about the stop signs on High Street and 5th Street when the development Village at Hobson Square. Councilman Lester told him as of now there is a two-way stop sign on the plan.

- a) Borough Manger Saginario gave the Personnel, Finance & Admin. Committee report. The following topics were discussed: March treasurer reports & financial reports, 2025-2026 Health benefits, part-time clerk, crime watch, lobby repairs, and PW employee's updates. - b) Parks & Recreation Committee meeting was canceled this month.
- c) Public Safety Committee meeting was canceled this month.
- d) Bob Hayes, Chairman gave the Public Works & Facilities Committee report. The following topics were discussed: clearing Hobson Street at the end of the road, spring cleaning at the parks, batting cages are ordered, and Tatamy Farms final walkthrough. The next meeting is on April 9th, 2025.

PUBLIC SAFETY REPORTS

- a) PD Chief Snyder was not present at the meeting. Borough Manager Saginario gave the Police Report. The Police Department had a total of 79 calls, 51 traffic stops, 11 citations, 6 written warnings, and 34 verbal warnings. The department signed up for Crime Watch and it is for the public to know more on what is going on with the Tatamy Borough Police Department.
- b) FD Chief McDonald was not present at the meeting, Council President Hayes gave the Fire Company Report. The FD was dispatched to 2 incidents, had 31 daily activities, and had 1746.73-man hours this month. The FD will be attending the Easter Egg Hunt.
- c) Don Dereamus EMC was not present at the meeting to give the report.
- d) Jim Macort, Zoning Officer gave the Zoning & Code Officer Report. Had 9 inspections, 3 permits issued, and 6 residents called for outstanding fees still owed.

PRESIDENT'S CORRESPONDENCE

Council President Hayes had no comments.

CURRENT BUSINESS

a) Easter Egg Hunt, Final Preparations

The Council discussed the weather forecast for the easter egg hunt and as to what to do if its bad weather. The Council left it up the Borough Office to make the call as to have it, postpone or cancel the easter egg hunt.

b) 5K Run Discussion

The Council had an open discussion on the 5K Fun Run to change the date because having it the morning of the Fall Fest will be too much as we are moving it down to the Fire Company. The Community and Economic Development Committee will decide on when to have it another day. More information to come on the 5K Run.

c) Traffic Pole Replacement

A driver hit the traffic pole on Commerce & 8th Street. The driver has minimum insurance, and the insurance company will not cover the amount of the pole. The Borough Office is in discussions with the driver insurance company and the Boroughs to get an update on what the next steps are.

d) Crime Watch Update

The Police Department now has Crime Watch to help the Borough residents know and stay updated on what is happening in the Borough and the Police Department.

e) Insurance Renewal Updates

The Health Insurance the Borough has now is increasing 6.7% in cost. There is a plan that is a little different but is only a 2.7% increase in the cost. The Council had an open discussion and decided to go with the different insurance with a lower cost increase.

Councilman Wagner makes a motion to approve the change of the health insurance plan. Councilman Frey seconds this motion. Motion passes unanimously.

f) Zoning Hearing Board, Chrin Commerce Centre

Manager Saginario updated the Council that the Zoning Hearing board accepted the latest sketch plan for an entrance only to the development of Chrin SE Quad, therefore there is not a need to appeal the decision.

g) 2026 Priorities, Grant Application Discussion

Borough Manager Saginario informed the Council to decide at the Committee meetings if any committee wants to go in for a grant in 2026.

h) Band Contract, Fall Fest

Councilwoman Frace makes a motion to approve the band contract for Fall Fest on October 11th, 2025 for Brian Dean Moore Band. Councilman Wagner seconds this motion. Motion passes unanimously.

i) Acknowledge Public Works Resignation Letter

Councilman Frey makes a motion to acknowledge Public Works Resignation Letter. Council Pro-Tempore Porter seconds this motion. Motion passes unanimously.
