Ordinance Amendment, Title XV: Land Usage, Chapter 155- Zoning ARTICLE IV, Section 403.5(c) - Fences

(Duly Adopted 7th day of August 2023)

AN ORDINANCE OF THE BOROUGH OF TATAMY, NORTHAMPTON COUNTY, PENNSYLVANIA, AMENDING ZONING ORDINANCE, ARTICLE IV, SECTION 403.5(c): FENCES PROVIDING FOR REGULATIONS AND PROCEDURES.

SECTION 403.5

C. FENCES

- 1. Any fence located in the required front yard of a lot in a residential district, shall have a minimum ratio of 3:1 open to structural areas, shall not exceed 4 feet in height and shall be constructed entirely of wood (and any fasteners required, and any wire mesh attached on the inside of the fence).
- 2. Fences shall not be required to comply with the rear and side yard setbacks for accessory structures unless the fence would abut a public street.
- 3. A fence located in a residential district in a location other than the front yard shall have a minimum height of 4 feet.
- 4. A fence shall not be required to comply with accessory structure setbacks. Except that no fence shall be build within 5 feet of a right-of-way, future right-of-way line of a street and a fence in a residential district shall be setback from the property line the following distances:

| i. | Single Family Dwelling | 1-1/2 feet |

5. No fence shall be located within the paved area setback required under Section 603, nor within a drainage or utility easement in such a way that it would prevent use of the easement for its intended purpose.

ZONING ORDINANCE ARTICLE IV, SECTION 403.5(C) - FENCES

- 6. Any fence that has one side that is smoother ang/or more finished than a second side shall place the smoother side and/or more finished side so that it faces away from the area that is enclosed, unless the fence abuts a business use.
- 7. The following exceptions are set forth for fence location pertaining to setbacks and locations pertaining to properties with setbacks.
 - i. Proposed fences that will not be located completely on the applicant's property, that cannot be maintained completely from the applicant's side or within the 1-1/2-foot setback, the applicant must obtain a written and notarized agreement by each adjoining property owners(s) where the fence is proposed, waiving the specific provisions of this chapter, claiming ownership and responsibility of said fence and filed by the Borough Zoning Officer. Location of property lines will be the responsibility of the applicant to verify, through a surveyor's account, the precise location of property lines.

The Borough shall not be responsible, through the issuance of a fence permit or otherwise, for any damages or dispute which may arise through the issuance of a fence permit or approving the placement of any fence, where the applicant for a permit has submitted or relied on a survey plat or marker which is in error or at a variance with that of a neighbor.

- ii. Fences placed within easements must have approval from the Borough Zoning Officer and Borough Council. The applicant must agree to be responsible for all legal costs incurred by the creation and approval of an Easement Agreement with the Borough and recorded in the Office of Recording Deeds for Northampton County, if approved.
- 8. No part of this Ordinance shall prohibit a developer from establishing Deed restrictions or homeowner association regulation that further restricts the height, location, and material of fences in addition to those set forth herein.




